This 76mm lock case (offering a **57mm backset**) is specifically built to accommodate a **Euro Profile Cylinder**, allowing you the flexibility to choose between keyed-alike systems, master key suites, or thumbturn cylinders for easy egress.

- **Flexibility:** Unlike a fixed 5-lever mortice lock (where the whole lock must be replaced if keys are lost), the Eurospec Deadlock uses a **Euro Cylinder**. This means you can upgrade the cylinder to an anti-snap/anti-pick version (like a 3-star Kitemark) without changing the entire deadlock mechanism.
- **Longevity:** Standard locks typically offer a 1-2 year warranty. Eurospec provides a **10-25 year mechanical guarantee**, making it a "fit and forget" solution for high-traffic areas.

Frequently Asked Questions (FAQ)

1. Does this lock come with the key cylinder?

No, this is the lock case only. You will need to purchase a Euro Profile Cylinder (Double, Single, or

Cylinder & Turn) separately to operate the lock.

2. What is the difference between a 64mm and 76mm deadlock?

The 76mm refers to the total depth of the lock case. A 76mm lock provides a 57mm backset, which places the keyhole further away from the door edge – this is often preferred for aesthetics or to prevent fingers from catching on the frame.

3. Is this lock suitable for fire doors?

Yes. It is Certifire tested and suitable for use on FD30 and FD60 fire doors. We recommend using it in conjunction with an intumescent lock kit to maintain the door's fire integrity.

4. Can I use this on a uPVC door?

This specific mortice deadlock is designed primarily for timber (wooden) doors. While uPVC doors use Euro Cylinders, they typically require multi-point locking mechanisms rather than a single mortice case.
